(1) CHANGE OF COMPANY NAME; (2) CHANGE OF STOCK SHORT NAMES; AND (3) CHANGE OF COMPANY WEBSITE

References are made to (i) the announcements of Metaspacex Limited (formerly known as Yield Go Holdings Ltd.) (the “**Company**”) dated 13 June 2024 and 2 July 2024; (ii) the circular of the Company dated 5 July 2024 (the “**Circular**”) in relation to, among others, the Proposed Change of Company Name; (iii) the announcement of the Company dated 22 July 2024 in relation to the poll results of the EGM held on 22 July 2024; and (iv) the announcement and the supplemental announcement of the Company both dated 26 July 2024 in relation to the Change of Company Name (the “**Change of Company Name Announcements**”). Capitalised terms used herein shall have the same meanings as those defined in the Circular unless defined otherwise.

(1) CHANGE OF COMPANY NAME

As disclosed in the Change of Company Name Announcements, the English name of the Company has been changed from “Yield Go Holdings Ltd.” to “Metaspacex Limited”, and the dual foreign name in Chinese of the Company, being “耀高控股有限公司” has been dispensed. Subsequent to the Change of Company Name Announcements, the Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 12 August 2024 under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

Effect of the Change of Company Name

The Change of Company Name will not affect any of the rights of the Shareholders. All existing Share certificates in issue bearing the former name and logo of the Company will continue to be good evidence of title to the Shares of the Company and remain valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for free exchange of the existing Share certificates for new certificates bearing the new name of the Company. New share certificates will be issued in the new name of the Company.

(2) CHANGE OF STOCK SHORT NAMES

With effect from 9:00 a.m. on 27 August 2024, the existing English stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “YIELD GO HLDGS” to “METASPACEX”, and the existing Chinese stock short name of “耀高控股” will be dispensed with and no Chinese stock short name will be adopted by the Company. The stock code of the Company remains unchanged as “1796”.

(3) CHANGE OF COMPANY WEBSITE

With effect from the date of this announcement, the website of the Company has been changed from “http://www.yield-go.com” to “www.metaspacex.hk”, to reflect the Change of Company Name. All announcements, notices or other documents to be submitted by the Company for publication on the Stock Exchange’s website will also be published on this new website of the Company.
